## About us

NLA is made up of 8 statewide Legal Aids who provide legal assistance to Australians experiencing disadvantage. The Legal Aids receive\$1.79 billion under the National Access to Justice Partnership to deliver family law and national civil law legal assistance

Each year under the NAJP we deliver:

- 32,000 family law legal representation
- Respect@Work, domestic & family violence, migration & income support legal assistance
- Non-legal supports such as social supports and law reform work.

72% of representation grants are handled by private lawyers.

Clients receiving legal representation include:

- 24% First Nations people
- 25% people with disabilities
- 100% under the poverty line

## **Purpose**

## Who we are

NLA is made up of 8 statewide Legal Aids (LAs) who provide legal assistance to Australians experiencing disadvantage.

## Who we support

We are the 'safety net' of the legal system – offering to assist families and individuals in times when they are in highest need. We are the main providers of legal representation in criminal, government

and family law nationally. Our clients include people most in need of legal assistance including First Nations peoples, victim-survivors of domestic violence, and people with disabilities.

## What we offer

Each year we deliver:

## 1.7 million legal assistances

150,000 legal representation grants.

## Legal Aid services include: Legal Advice

Advice on various legal issues, including family law, criminal law, civil law, workplace and tenancy disputes.


## **Duty Lawyer Services**

Lawyers available at courts to assist with urgent legal matters, including representation for people facing criminal charges or family law proceedings.

## **Legal Information**

Online and telephone services that provide general legal information and referrals.

## **Legal Representation**

Legal Aid provides lawyers to represent eligible clients in court, especially in serious criminal matters, family law disputes, and child protection cases.

#### **Dispute Resolution Services**

Assistance with mediation and alternative dispute resolution, especially in family law matters such as parenting arrangements.

## **Community Legal Education**

Community Legal Education Programs to help the public understand their legal rights and responsibilities.

72% of representation grants are delivered by private lawyers.

## **Our impact**

## Family Law & Domestic Violence

86% of 32,000 family law representation grants involve risks of family violence.

Independent Children's Lawyers (ICLs) provide 6,000+ grants yearly to protect at-risk children.

## **Crisis Response**

Delivering disaster legal assistance for communities affected by floods and bushfires including5,000+ legal assistances during 2022 floods in NSW.

#### **Advocacy**

Led joint action against Robodebt, resulting in \$1.76 billion in waived and refunded 'debts' issued to over 443,000 people.
